When in Rome (or Manila ...): Where Business, Law and Ethics Meet²

Ben Rasmussen was a young mid-level international business development manager with a quickly growing software company in the midwestern United States and happily married. He and his wife just had had their first child in June. It was now early July, and Ben found himself on a business trip to the Philippines. Ben had successfully identified and recruited his company's first independent distributor in the Asian market, located in the Philippines. He now had been invited to the capital Manila to present at the main conference introducing the company's software products. This was a very important event to launch the products in Asia which the company viewed as a significant growth area in its overall global business expansion. It was also an important stepping stone for his personal career. He was the only company representative at the event and his successful presence would likely result in additional business opportunities for the company. He had already traveled to several countries around the world - but never to Asia. His approach to business - and to life - was simple. Ben was a straight shooter: What you saw is what you got. Ben did not lie or cheat, and he followed the rules. His approach was about to face a major test on this assignment.

After flying over 22 hours from the United States and crossing the international date line, Ben landed at Ninoy Aquino International Airport in Manila very late in the evening. I will have a driver pick you up at the hotel at 6:30 p.m." Despite his fatigue, Ben did not feel he could turn down the invitation and agreed to join.

The group enjoyed a wonderful dinner and drinks at a high-end Chinese restaurant. In addition to the two other speakers, who worked for potential partner companies in Tokyo and Hong Kong, two of James's employees had joined them. The dinner wrapped up at about 10 p.m. when James asked the group to join him in "something typically Asian." Two cars picked up the men to drive to a different location. Ben fell asleep during the 30-minute drive. He woke up when the car stopped, and his door was opened. As he groggily stepped out of the car, he realized that he did not know where he was or how to get back to his hotel. He also noticed a row of brightly-lit buildings.
